early childhood arena. During her 22 years of service to the Forum, Dr. Kalifeh became established as a highly respected leader in the field, who was dedicated to research-based solutions that work. Her hard work has improved the lives of millions of children as well as those who care for them. Thanks, Dr. Kalifeh!

I am happy to announce that Dr. Kalifeh's successor as President and CEO is Erin Smeltzer. She is energetic and creative and will carry the Forum to new heights. Erin has spent her career working for many organizations that support early learning programs, and she is excited to assume the helm. I look forward to working with Erin on the Board's long-range plans to stay current in our evershifting environment.

The Forum's signature work of administering the T.E.A.C.H Early Childhood® Scholarship Program and Help Me Grow® Florida continues. This year's \$10 million appropriation for T.E.A.C.H. and \$1.8 million for Help Me Grow was supported by the legislature and governor. T.E.A.C.H. helps to improve the compensation, education, and retention of early educators while Help Me Grow provides screenings, resources, and follow-up services to families with concerns about their child's behavioral health and development.

In addition to T.E.A.C.H. and Help Me Grow, the Forum is looking to expand the Early Childhood Educator INCENTIVE\$ Florida program into more counties. INCENTIVE\$ provides financial stipends to early educators based on their education and continuity of care. This program helps to attract and retain qualified staff.

Given the critical work they do, we know that early educators deserve living wages. We also know that families need affordable accessibility to high-quality child care programs. The exciting news is that the business community is recognizing the long-term benefits of investing in early care and education. Just recently, the Florida Philanthropic Network, a large group of Florida's grantmaking foundations, turned their focus to early childhood. They know that to have the greatest effect, we need to start early!

## Children's Week Florida<sup>™</sup>

Children's Week Florida™ is the largest event held in the state that celebrates and honors its commitment to children, youth, and advocates. As the Organizing Partner for Children's Week Florida™, the Forum has taken the lead with helping to bring thousands of attendees, including legislators, public officials, nonprofit organizations, business leaders, child and youth advocates, teachers, and students, to the State Capitol each year during the legislative session. Together with our generous partners, we speak out as "One Voice" in support of children and families to deliver the message that every child should be healthy, ready to learn, and able to achieve their full potential.

## T.E.A.C.H. Early Childhood® Scholarship Program

The T.E.A.C.H. Early Childhood® Scholarship Program (T.E.A.C.H.) is an evidence-based strategy that helps to establish a well-qualified, fairlycompensated, and stable workforce for Florida's children.

Funded by the Florida Department of Education-Division of Early Learning and operated by the Children's Forum, T.E.A.C.H. provides scholarships and additional supports for early educators, directors, and owners working towards initial and renewal early learning credentials, college credit certificates, and degrees in early childhood education.

T.E.A.C.H. maintains a three-way partnership in which the early childhood educator, the sponsoring program (the scholar's employer), and T.E.A.C.H. share the costs for classes, books, and time away from work. Scholars earn a raise or bonus after the successful completion of an educational year and agree to work for at least one year with their sponsoring program.

## **Early Childhood Educator INCENTIVE\$** Florida

Early Childhood Educator INCENTIVE\$ Florida, an affiliate of Child Care WAGE<sup>\$®</sup>, rewards early childhood educators with financial incentives based on their education and continuity of employment. By retaining the early childhood workforce, INCENTIVE\$ provides children with more stable relationships and better-educated teachers. INCENTIVE\$ addresses individual professional development efforts and low wages, but does not affect budgets, regular wages, or parent fees within the child care program. INCENTIVE\$ is licensed by Child Care Services Association of Chapel Hill, NC and administered by the Children's Forum under a contract with local early learning coalitions, children's services councils, and private contributors. Through these partnerships, INCENTIVE\$ is enhancing the professional development of early childhood educators to improve the quality of child care programs.

# **PROGRAMS OF THE CHILDREN'S FORUM 2021-2022**

## Help Me Grow<sup>®</sup> Florida

Help Me Grow<sup>®</sup> Florida (HMGF) promotes the healthy development of all children by providing access to free developmental and behavioral screenings and connecting families to the resources they need to succeed. By building cross-sector collaboration among community agencies, child healthcare professionals, and early childhood educators, HMGF addresses the critical importance of early detection and intervention. HMGF provides a centralized access point that supports families through developmental monitoring, parenting information, and available community resources. Since HMGF care coordinators continue to follow-up with families, HMGF can ensure that the needs of the family have been met.

## **Early Learning Career Center**

Operated by the Children's Forum and funded by The Children's Trust (TCT), the Early Learning Career Center (ELCC) offers professional development services to all early learning programs and educators in Miami-Dade County. The ELCC, which is part of the Miami-Dade Early Learning Quality Improvement System (QIS), provides career advising and TCT Educator Scholarships in support of a diverse workforce. The ELCC also connects early childhood educators in Miami-Dade to other professional development supports such as the T.E.A.C.H. Early Childhood Scholarship Program and salary incentives funded by TCT.

## Impact and Outcomes:

**76%** of educators recently received TCT scholarships and/or

80% of educators obtained a credential since entering the QIS.

## **Professional Development Registries**

The Children's Forum maintains two professional development registries, the Miami-Dade Professional Development Registry and the Palm Beach County Training Registry. These registries provide a central database to record the workforce qualifications of early childhood educators, such as employment history, compensation, benefits, credentials earned, and college courses/training activities completed. Funding for the Miami-Dade Professional Development Registry and Palm Beach County Training Registry is provided by The Children's Trust and the Children's Services Council of Palm Beach County.

## **Assessment and Coaching Services Unit**

The Children's Forum holds a contract with the Florida Division of Early Learning for providing Classroom Assessment Scoring System (CLASS<sup>®</sup>) observation and coaching services within each county in Florida. The Forum offers CLASS<sup>®</sup> services to early learning coalitions, Head Start agencies, and other entities to help them meet state and federal program assessment requirements and improve early childhood classroom practices. The Forum has provided CLASS<sup>®</sup> services in every region and over half of the counties in Florida.

## Impact and Outcomes:

65 certified CLASS® assessors and coaches were available to provide services.

24 agencies received CLASS<sup>®</sup> services.

1,757 early learning programs received assessments.

4,837 assessments were conducted.

## **Child Care Evaluation Services**

The Child Care Evaluation Services Department provides the following accreditation management and educational support services for the Florida Department of Education - Division of Early Learning and Florida Department of Children and Families (DCF), Office of Licensing:

- ★ Evaluating applications from prospective Florida Child Care Professional Credential (FCCPC) training institutions to determine their eligibility to offer the FCCPC, and monitoring the status of all FCCPC training programs in the state
