## MESSAGE FROM THE **BOARD CHAIR**



The Children's Forum is hard at work to improve access to quality early learning programs for families with young children. It is beyond dispute that children with access to quality early education are better prepared to succeed in school and later in life.

I am thankful for our legislators and their support of transforming the state and the early education industry to make early learning more accessible and affordable for Florida's families.

Access also means getting the right care for each child's needs. The Forum is proud to administer Help Me Grow<sup>®</sup> Florida, which provides a centralized access point to support families through developmental monitoring, follow-up services, parenting information, and available community resources. Help Me Grow<sup>®</sup> Florida has connected 4,100 families to the services they needed.

The Forum is a key part of the ongoing and necessary transformation from "daycare" workers to "early learning educators." The Forum administers the T.E.A.C.H. Early Childhood® Scholarship Program and Early Childhood Educator INCENTIVE\$ Florida, which increase the education, compensation and retention of the early learning workforce. Recipients of these programs qualify for increased pay and learn new skills to educate young children. We are honored to help thousands of educators as they learn and grow within their profession.

I can offer a personal story to show that access and high-quality early learning programs make all the difference. My wife and I recently adopted a charming 5-year-old. He had all the strikes against him - single mom in poverty, born on Medicaid, no involved father, and time spent homeless. But he is thriving in first grade and has a full future ahead of him. All the credit goes to the high-quality early learning experiences that he received at Early Head Start at age two and an excellent preschool in Tampa at ages three and four. He was Kindergarten-ready and is off to the races.

I know it is absolutely possible for every child in Florida to arrive at kindergarten ready for success. The Forum will be a key player in making that happen for every child. Together, let's work to strengthen Florida's early learning systems to make an impact at both a statewide and national level for many years to come.


#### T.E.A.C.H. Early Childhood<sup>®</sup> Scholarship Program

The T.E.A.C.H. Early Childhood<sup>®</sup> Scholarship Program (T.E.A.C.H.) is an evidence-based strategy that helps to establish a well-qualified, fairly-compensated, and stable workforce for Florida's children.

Funded by the Florida Department of Education - Division of Early Learning, T.E.A.C.H. is operated by the Children's Forum. T.E.A.C.H. provides scholarships and additional supports for early learning educators, directors, and owners working toward early learning credentials, college credits, and degrees in early childhood education.

T.E.A.C.H. maintains a three-way partnership in which the early learning educator, the sponsoring program (the scholar's employer), and T.E.A.C.H. share the costs for classes, books, and study time away from work. Scholars earn a raise or bonus after the successful completion of an educational year and agree to work for at least one year with their sponsoring program.

#### Impact and Outcomes:



#### Help Me Grow<sup>®</sup> Florida

Help Me Grow<sup>®</sup> Florida (HMGF) promotes the healthy development of all children by providing access to free developmental and behavioral screenings and connecting families to the resources they need to succeed. By building cross-sector collaboration among community agencies, child healthcare professionals, and early childhood educators, HMGF addresses the critical importance of early detection and intervention.

HMGF provides a centralized access point that supports families through developmental monitoring, parenting information, and available community resources. Since HMGF care coordinators continue to follow-up with families, HMGF can ensure that the needs of the family have been met.

#### Impact and Outcomes:



#### Early Childhood Educator INCENTIVE\$ Florida

Early Childhood Educator INCENTIVE\$ Florida, an affiliate of Child Care WAGE\$<sup>®</sup>, rewards early learning educators with annual stipends as they further their education and maintain continuous employment. By retaining the early learning workforce, INCENTIVE\$ motivates participants to pursue higher education and provides children with more stable relationships in their classrooms.

INCENTIVE\$ is licensed by Child Care Services Association of Chapel Hill, NC and administered by the Children's Forum under a contract with local early learning coalitions, children's services councils, and private contributors. Through these partnerships, INCENTIVE\$ is an early learning quality initiative that helps enhance the professional development of early learning educators and improve the quality of child care programs.

#### Impact and Outcomes:



The average turnover rate for INCENTIVE\$ participants was



compared to 30-40% turnover in the field nationally.

## **PROGRAMS OF THE CHILDREN'S FORUM** 2022-2023

#### Children's Week Florida<sup>™</sup>

Children's Week Florida<sup>™</sup> is the largest event held in the state that celebrates and honors its commitment to children, youth, and advocates. As the Organizing Partner for Children's Week Florida™, the Forum has taken the lead with helping to bring thousands of attendees, including legislators, public officials, nonprofit organizations, business leaders, child and youth advocates, teachers, and students to the State Capitol each year during the legislative session. Together with our generous partners, we speak out as "One Voice" in support of children and families to deliver the message that every child should be healthy, ready to learn, and able to achieve their full potential.

#### Impact and Outcomes:





400 guests attended the Advocacy Dinner and Awards Ceremony. Dr. Mimi Graham received the Chiles Advocate Award while Sruthi Sentil was the recipient of the Youth Advocate Award.

Approximately **1,500** young children, students, and teachers attended Children's Day at the Capitol and Storybook Village events.



More than **16,000** pieces of hand artwork were collected for the Celebration of the Hands display inside the Capitol Rotunda.

#### **Early Learning Career Center**

Operated by the Children's Forum and funded by The Children's Trust (TCT), the Early Learning Career Center (ELCC) offers professional development services to all early learning programs and educators in Miami-Dade County. The ELCC, which is part of the Miami-Dade Early Learning Quality Improvement System (QIS), provides career advising and TCT Educator Scholarships in support of a diverse workforce. The ELCC also connects early childhood educators in Miami-Dade to other professional development supports such as the T.E.A.C.H. Early Childhood<sup>®</sup> Scholarship Program and salary supports funded by TCT.

#### Impact and Outcomes:

73% of educators recently received TCT scholarships and/or salary supports.

83% of educators obtained a credential since entering the QIS.

#### **Professional Development Registries**

The Children's Forum maintains two professional development registries: the Miami-Dade Professional Development Registry and the Palm Beach County Training Registry. These registries provide a central database to record the workforce qualifications of early learning educators, such as employment history, compensation, benefits, credentials earned, and college courses/training activities completed.

Funding for the Miami-Dade Professional Development Registry and Palm Beach County Training Registry is provided by The Children's Trust and the Children's Services Council of Palm Beach County.

#### Impact and Outcomes:

#### **Assessment and Coaching Services Unit**

The Children's Forum holds a contract with the Florida Division of Early Learning for providing Classroom Assessment Scoring System (CLASS®) observation and coaching services within each county in Florida. The Forum offers CLASS<sup>®</sup> services to early learning coalitions, Head Start agencies, and other entities to help them meet state and federal program assessment requirements and improve early childhood classroom practices. The Forum has provided CLASS<sup>®</sup> services in every region and over half of the counties in Florida.

#### Impact and Outcomes:

70 certified CLASS® assessors early learning programs and coaches were available received assessments. to provide services. 3,386 assessments were conducted. agencies received CLASS® services.

#### **Child Care Evaluation Services**

The Child Care Evaluation Services Department provides the following accreditation management and educational support services for the Florida Department of Education - Division of Early Learning and Florida Department of Children and Families (DCF), Office of Licensing:

- ★ Evaluating applications from prospective Florida Child Care Professional Credential (FCCPC) training institutions to determine their eligibility to offer the FCCPC, and monitoring the status of all FCCPC training programs in the state
- ★ Evaluating applications from prospective and renewing accrediting
