

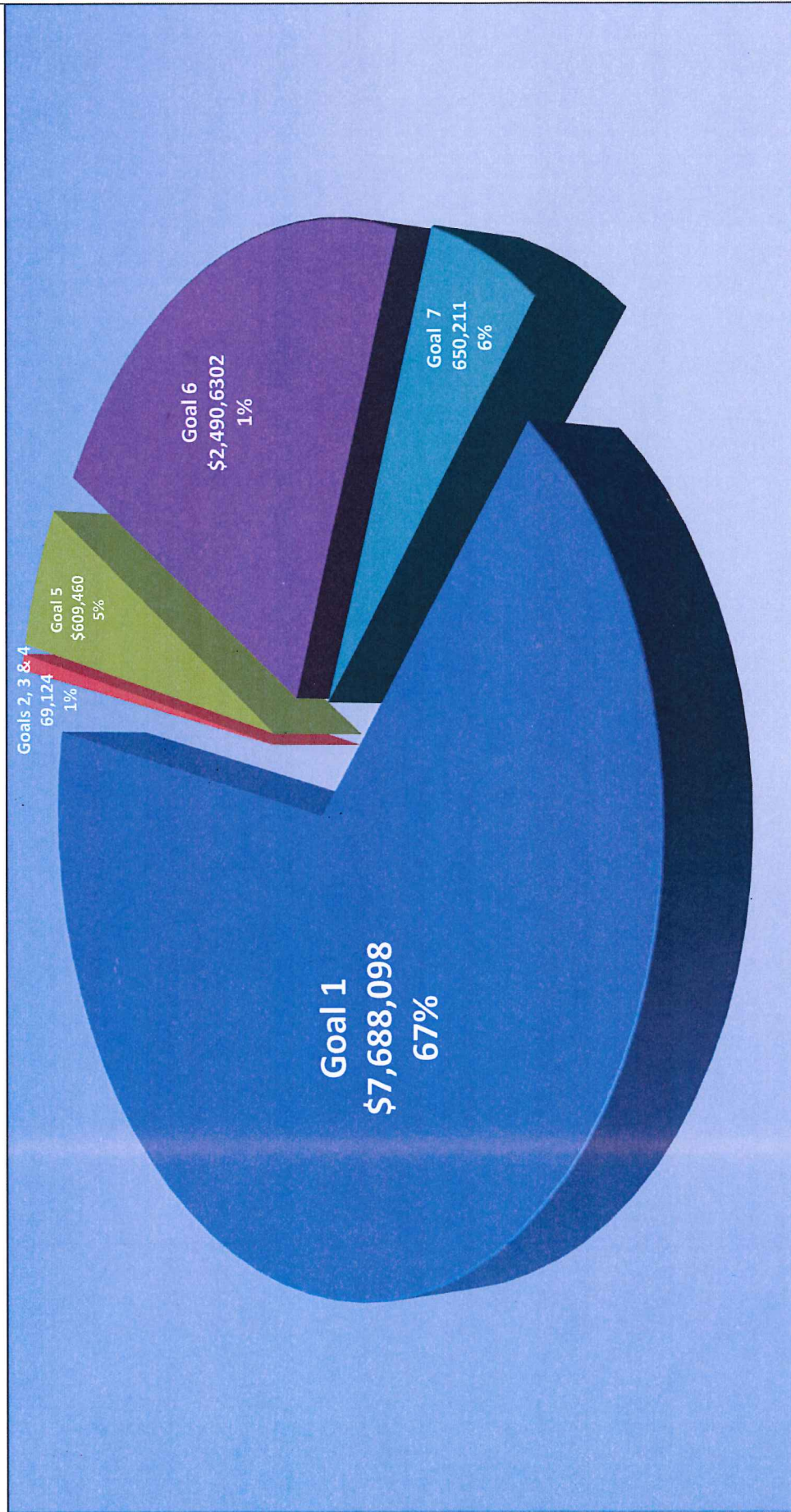

## Budget by Goal

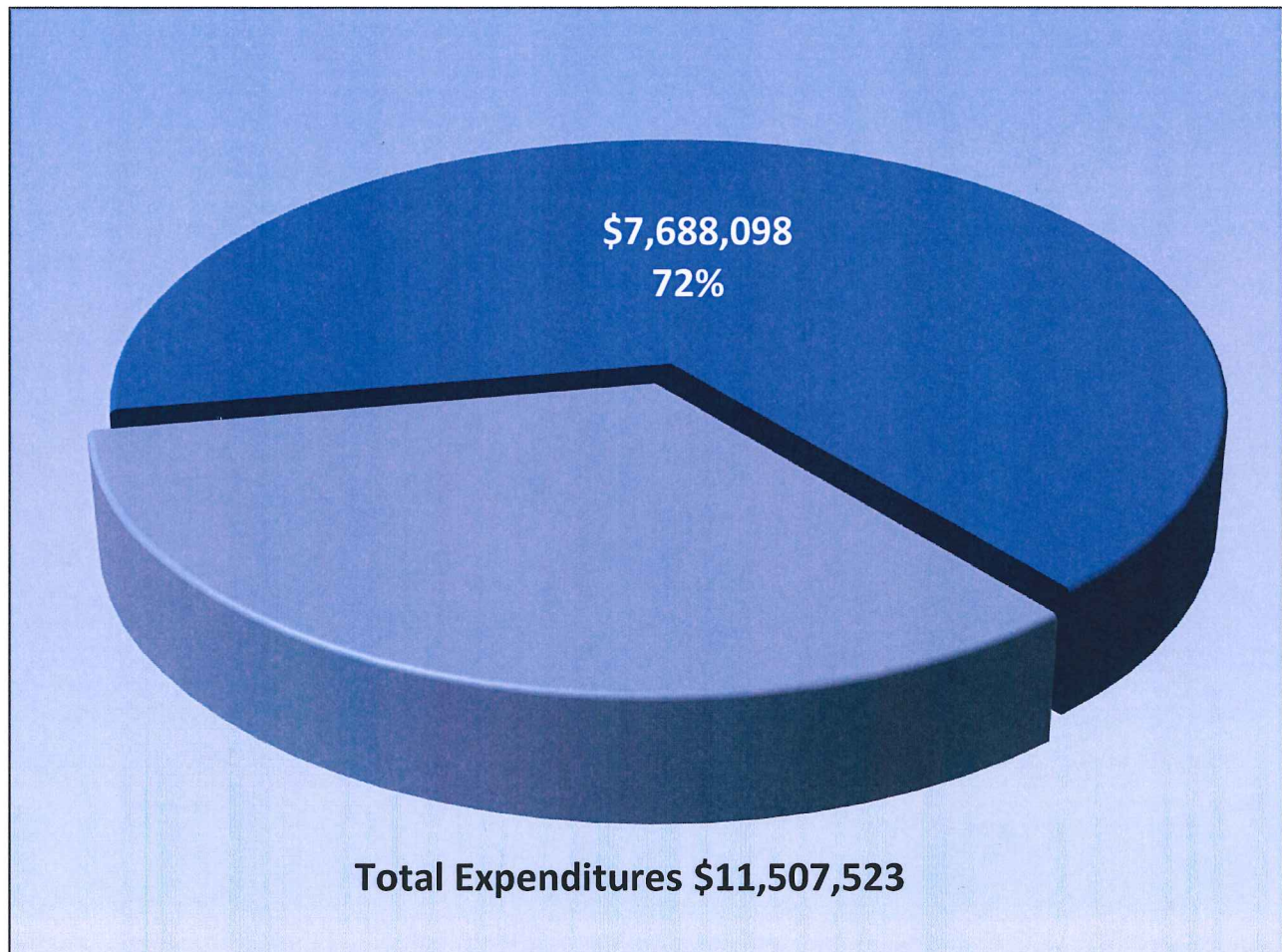


Total Budgeted Income & Expenditures FY178 - \$11,507,523

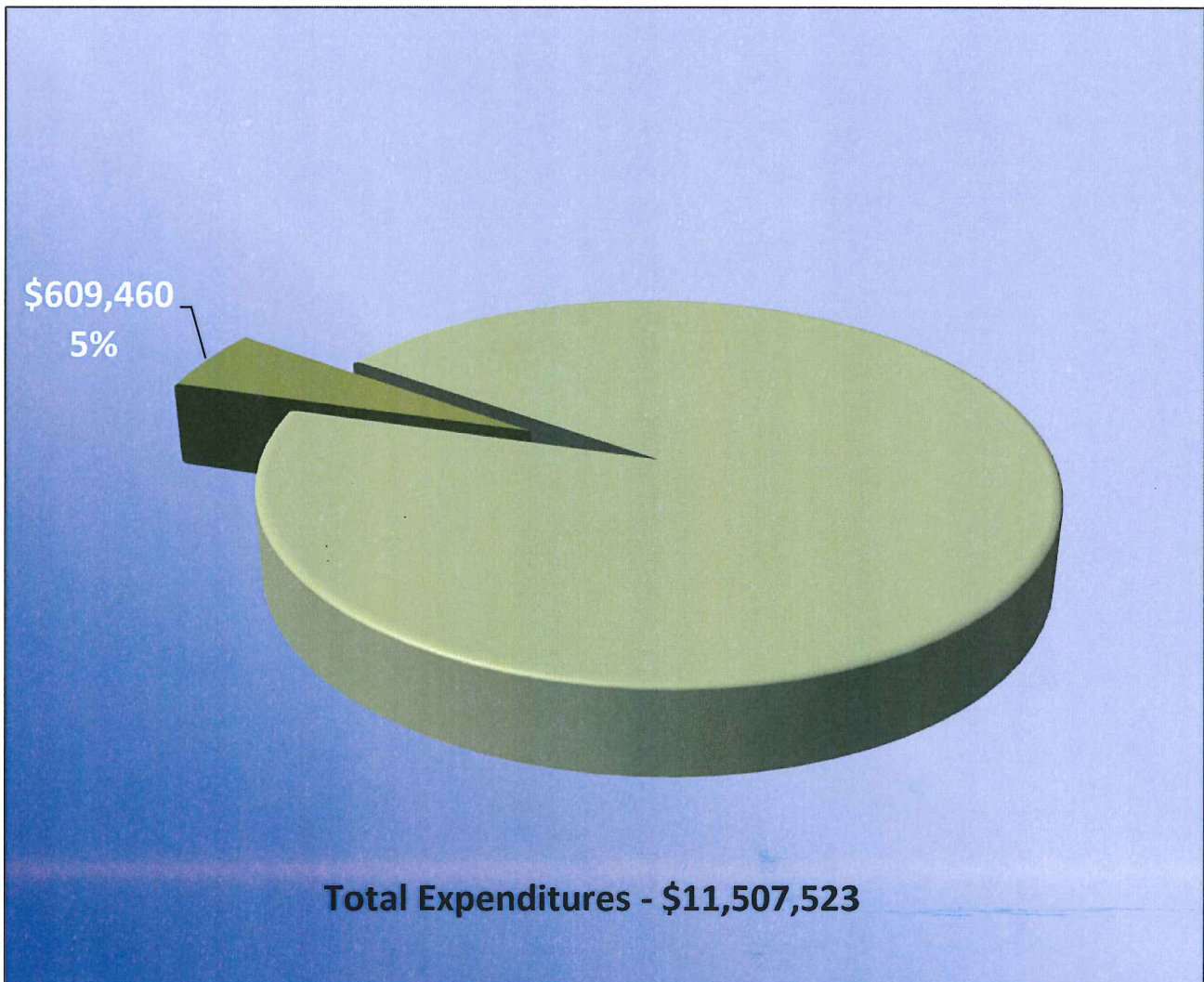

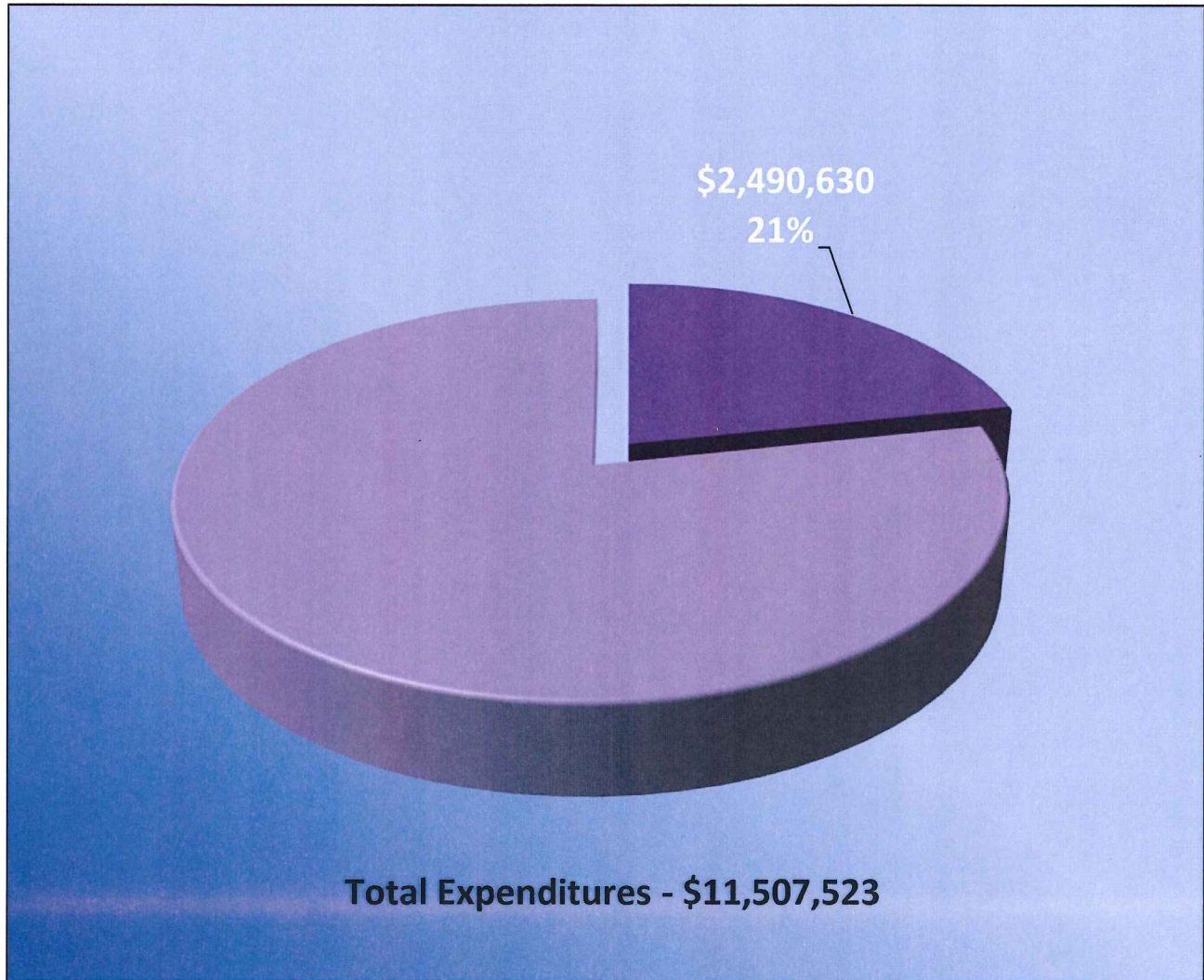

The Children's Forum will provide collaborative leadership and develop tools (strategies) to improve systems of care, education, and healthy development for all children and youth.



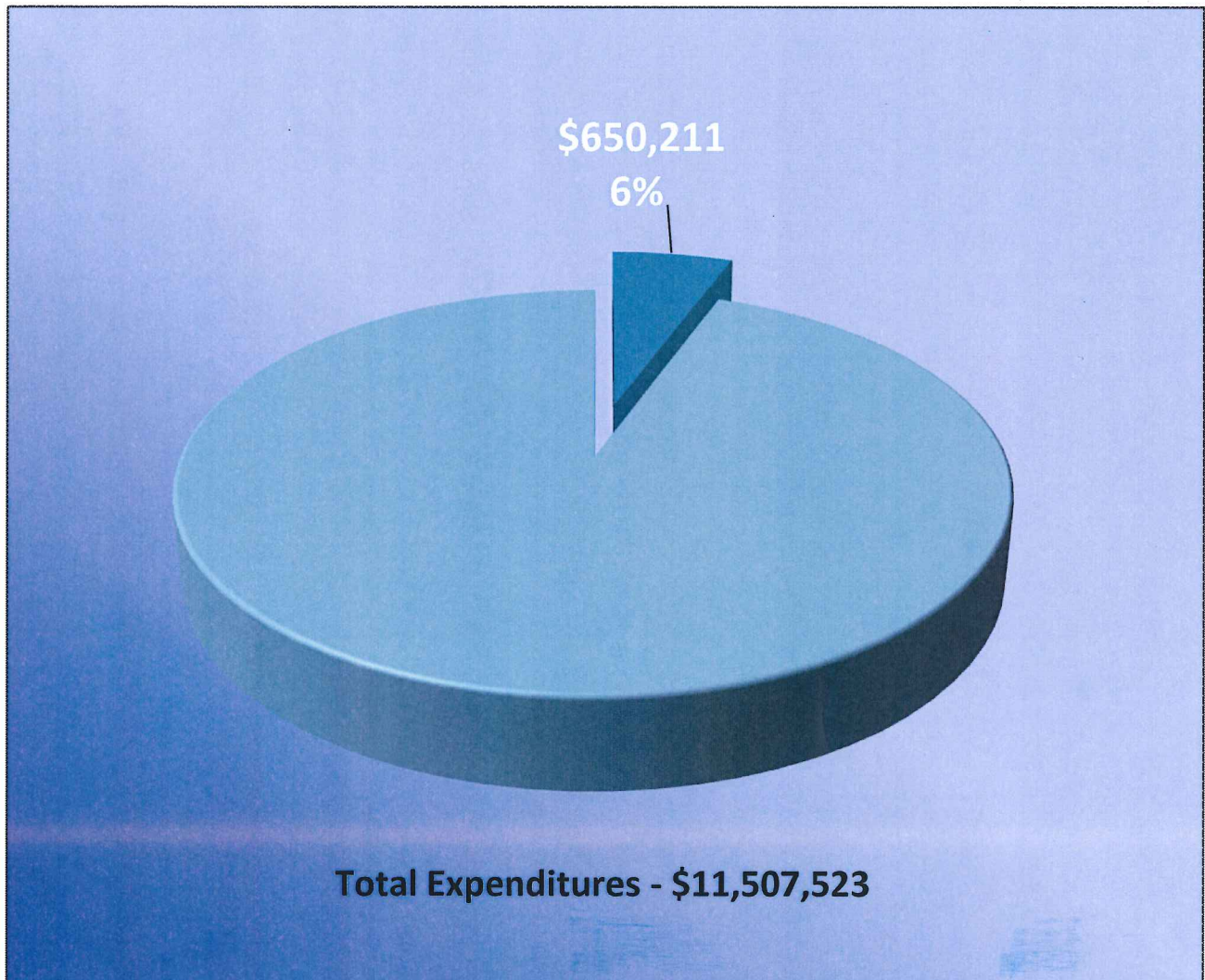
