NOTICE OF INTENT TO FIND SUBSTANTIVE CHANGE AND ISSUE PROVISIONAL
LICENSE WITH CONDITIONS

COMES NOW the Commission for Independent Education (hereinafter "the Commission") with its Order of Finding Substantive Change and Issuing Provisional License.

1. The Commission for Independent Education reviewed and considered your application at a duly-noticed public meeting held on November 22, 2024.

2. Based on the information provided, it is ORDERED that the Annual License is approved for procedural purposes.

3. Notwithstanding, Commission FINDS that a Substantive Change has occurred based on the change of location exceeding forty five miles and ORDERS that the institution be issued a Provisional License through November 30, 2025.

4. The Commission delegates authority to its Executive Director to return the institution to an Annual License, upon determination that the institution is in full compliance with Chapter 6E, F.A.C., that the changes noted above have no negative impact on the institution or the students, and upon the following contingency being met:

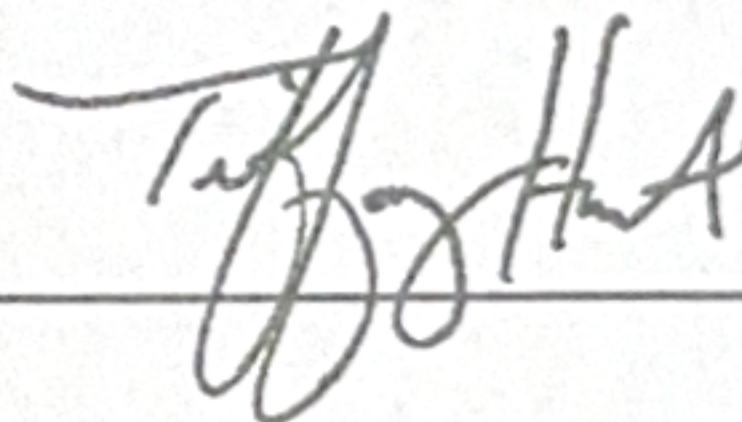
a. Submission of documentation confirming completion of an admissions training program for all staff who recruit prospective students or who participate in the admission of prospective students in compliance with Rule 6E-1.0032(13), F.A.C.

This condition shall be met, and all information received at the Commission office, within ninety days of this clerked order.

5. It is further ORDERED that the Child Development Education Alliance, Inc., Winter Haven, make timely and sufficient application for renewal of the license by submitting a complete application, materials, and fees, or an extension thereof, no later than 120 days prior to November 30, 2025.

This order becomes effective upon filing with the Commission for Independent Education.

NOTICE TO APPLICANT

You may seek review of this Order, pursuant to Section 120.569 and 120.57, Florida Statutes, by mailing a petition to the Executive Director of the Commission, Department of Education, 325 W. Gaines Street, Suite 1414, Tallahassee, Florida 32399-0400, within 21 days of receipt of this Order. Petitions may also be filed via fax to (850) 245-3233. **Petitions cannot be filed via electronic mail.**

If you dispute any material fact upon which the Commission's decision is based, you may request a hearing before an Administrative Law Judge pursuant to Section 120.57(1), Florida Statutes; your petition must contain the information required by Rule 28-106.201, Florida Administrative Code, including a statement of the material facts which are in dispute. If you do not dispute any material fact, you may request a hearing before the Commission pursuant to Section 120.57(2), Florida Statutes; your petition must include the information required by Rule 28-106.301, Florida Administrative Code.

Pursuant to Section 120.573, Florida Statutes, you are hereby notified that mediation pursuant to that section is not available.
